- I am aged 18 years old or over.
- I understand that I am responsible for ensuring the children listed below are actively supervised by an adult aged 18 years or over at all times while undertaking the activities. 'Active supervision' means remaining within eyesight with the ability to communicate easily.
- I agree that I am responsible for ensuring the children undertake the activities in accordance with the 'Conditions of Park Entry' and 'Park Safety Rules' I have been given the opportunity to read, and covered during the safety briefing. **I will ensure the children remain attached to the safety system at all times when accessing the courses.**
- I agree not to leave the adventure park grounds at any time whilst the children are participating in the activities.
- I will ensure all supervising adults attend the safety briefing with the children.
- I understand that there is a **risk of serious injury or death if the children do not follow the 'Park Safety Rules'** while undertaking the activities, and accept that there is an inherent risk of minor injuries due to the nature of the activities and the environment.
- I acknowledge that Tree Adventures is not liable for **any direct or indirect loss, damage or injury** arising from or in connection with the activities, with the exception of death or injury caused by the negligence of Tree Adventures and its staff.
- I am responsible for the **Personal Protective Equipment (PPE)** issued to the children and fitted by Park Staff and will return it in good condition. I will ensure the children do not share any item of PPE with anyone. I understand that I may be liable to pay any costs incurred due to intentional misuse or damage caused to the equipment.
- I acknowledge that the maximum weight to participate is 130kg.** If any of the participants listed weigh more than 100kg I accept that I am required to notify the park staff so they can verify their weight as additional safety equipment may be required.
- I understand that the activities are both **physically and psychologically** demanding in nature. I consider that the children are physically and mentally capable of sustaining the level of exertion and stress resulting from participating in the activities.
- I certify that to the best of my knowledge the children do not have any **medical conditions** (including pregnancy), **disabilities or special needs** that may affect their ability to participate safely or endanger the safety of others.
- I acknowledge that Tree Adventures will take all reasonable and practicable steps to keep the children safe while they are involved in the activities. However, I accept full responsibility for their actions or inaction.**
- I understand that **immediately after completing the safety briefing** we may choose to 'opt out' and request a partial refund if I am not comfortable taking responsibility for the personal safety of the children while they undertake the activities.
