- I understand that I am responsible for ensuring the children (or participants) are 'actively supervised' by a responsible adult at all times. I understand there are consequences if I ignore Tree Adventures safety management procedures, Park Staff instructions and supervision requirements (which I have read).
- I understand that the activities consist of high-wire obstacles and ziplines which are both physically and psychologically demanding in nature and require the children (or participants) to climb at heights ranging from 2 – 14 metres.
- I understand that there is a risk of serious injury or death while undertaking the activities and accept that there is an inherent risk of minor injuries due to the nature of the activities and the environment.
- To reduce the associated risks, I will ensure the children (or participants) are supervised at all times while undertaking the activities and they follow the 'Park Safety Rules' along with all instructions given to them by Park Staff before and during participation in the activities. **MOST IMPORTANTLY:** ensuring they remain attached to the safety system at all times while undertaking the activities.
- I understand that Tree Adventures have the authority to remove the children (or participants) from the activities if they fail to follow the 'Park Safety Rules' and Park Staff instructions. I accept no refund will be offered in this instance.
- To the best of my knowledge the children (or participants) do not have any pre-existing injuries or underlying physical conditions that would increase the likelihood of injury, illness or death as a result of participation in the activities.

**Please advise us of any pre-existing injuries or conditions:**

- To the best of my knowledge the children (or participants) do not have any medical conditions (including pregnancy), disabilities or special needs that may affect their ability to participate safely or endanger the safety of others.

**Please advise us of any medical conditions, disabilities or special needs:**

- I confirm that none of the children (or participants) exceed 130kg (maximum participant weight). If a child (or participant) weighs more than 100kg, I will notify Park Staff during check-in so their weight can be verified.
